Benchmark Family Services provides quality services including therapeutic case management services, 24 hour crisis intervention, and mental health treatment with a contracted psychiatrist and on staff therapists. Our goal is to provide stable and consistent placements to youth in care and will work with DCBS to prevent disruptions or unnecessary moves for children in care. Case managers provide detailed monthly Treatment Status Reports to the referring agency and include the referring agency in all treatment planning meetings. Each youth placed will complete a thorough psycho-social assessment by a qualified Treatment Director and identified needs will be addressed in the youth's treatment plan. Benchmark Family Services accepts referrals for placements twenty four hours a day, seven days a week. The Prestonsburg office offers Trauma Focused CBT Therapy.

Family is invited to Treatment Team meetings, visitation and they receive a copy of the treatment plan each time one is updated. Foster children are encouraged to remain in contact with their parents. Family therapy is available upon request from DCBS.
