Our services include weekly case management, 24-hour crisis support, mental health treatment, and ongoing basic living skill development. We will accept youth that do not have a high school diploma or GED (we will assist the youth with obtaining once in our program). All IL staff have been trained to complete the ASAP suicide assessment All therapeutic staff can complete substance abuse (PADDI-5) and domestic violence assessments for IL youth as well as offer C.A.R.E skill training (Child-Adult Relationship Enhancement skills building). All IL youth receive an initial assessment to identify immediate safety risks and determine mental health interventions. The IL youth is assigned a Necco clinician and case manager, and referred to a community-contracted psychiatrist, as needed. Referrals for treatment are made timely to ensure that the youth can receive services and avoid lapses in treatment. Necco will communicate with the previous psychiatric provider for medication management, as needed. Necco staff teaches IL youth about the importance and benefits of therapeutic services and medication management.

We also specialize in crisis interventions, family group decision making and critical stress debriefing.
