Our foster parents transport children to family visits; ensure phone calls are made/received as prescribed by treatment team and DCBS; and therapist assesses and provides family counseling when recommended by the treatment team and approved by DCBS as in the best interest of the child.

Special Interventions Available Internally

24/7 Crisis Intervention, case management, individual and family therapy, Substance Abuse Therapy, TF-CBT, Nurturing Parenting.
