Residents are allowed to attend dances, sports activities, etc with staff in attendance and on a case-by-case basis, or may attend by themselves with Social worker permission. Residents are allowed to interview and pursue employment. Staff encourage residents to save money earned during employment. Stepstone encourage, family involvement and fosters family involvement by offering counseling, transportation assistance, and visitation with SSW permission. Each of our residences has an active treatment team that consults daily to ensure each resident is offered unique and customized treatment which is documented on Individual Treatment Plans and on a daily task log with daily objectives. The treatment team encourages "out of the box" thinking to help the resident to be able to stay until his/her goals are met.
